

QA INSPECTOR I

Job Summary:

The Quality Assurance Inspector I shall assist in maintaining adherence of Marki products to our quality management guidelines. The QA Inspector I will report to QA Supervisor and will assist all production staff in production operations.

Primary Responsibilities:

This position is primarily responsible for inspecting product and materials at various stages of receiving and production and compile and evaluates statistical data to determine and maintain quality and reliability of products by performing the following duties personally or through subordinates.

- Approves incoming materials by confirming specifications; conducting visual and measurement tests; rejecting using tools such as calipers, thread gauges, pin gauges and returning unacceptable materials.
- Approves in-process production by confirming specifications; conducting visual and measurement tests; communicating required adjustments to production supervisor.
- Approves finished products by confirming specifications; conducting visual and measurement tests; returning products for re-work; confirming re-work.
- Documents inspection results by completing reports and logs; summarizing re-work and waste; inputting data into quality database.
- Keeps measurement equipment operating by following operating instructions; calling for repairs.
- Soldering and Assembly workmanship standards.
- Comply with Company standards associated with ISO: 9001 and AS9100.
- Identify errors in existing production documentation and assist quality and engineering staff to execute corrective action
- Maintains safe and healthy work environment by following standards and procedures; complying with legal regulations.
- Updates job knowledge by participating in educational opportunities; reading technical publications.
- Accomplishes quality and organization mission by completing related results as needed.
- Pulling and Stocking finished goods.



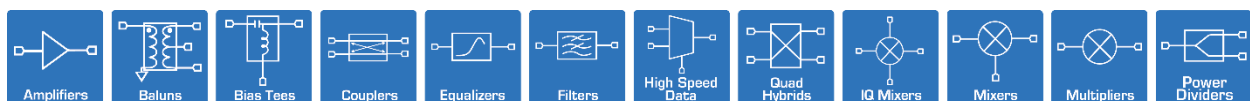
Physical Demands:
